To Affiliates and Other Creditors of Rex Venture Group, LLC:

Approval of the Rex Venture Group, LLC claims process has been one of the highest priorities for me, my team, and thousands of ZeekRewards affiliates. It is with pleasure that I report on May 8, 2013, the U.S. District Court for the Western District of North Carolina granted our motion seeking Court approval of our Claims Process for ZeekRewards. The complete, detailed Order Approving (I) Claims Process, (II) Setting of Bar Date, and (III) Approving Notice Procedures is available for review on this website under the heading "Case Documents."

**The Claims Process for ZeekRewards has not yet started. You cannot submit a claim until the online Claim Portal Opens.**

The online Claim Portal is scheduled to open on or before **May 15, 2013**. Any correspondence to me, my team, or to [info@zeekrewardsreceivership.com](mailto:info@zeekrewardsreceivership.com) is not a valid claim and will not be considered a valid claim. **ALL INDIVIDUALS WHO WISH TO RECOVER ON ACCOUNT OF THEIR CLAIMS MUST FILE A CLAIM USING THE COURT-APPROVED CLAIMS PROCESS.**

In order to submit your claim, you must wait until the online Claim Portal opens on or before **May 15, 2013**. We will send notice of the claims process to all affiliates for whom we have email addresses once the Claim Portal opens. These emails will be sent in stages between May 15 and May 22, 2013. During that time period, we will also send postcard notices to those affiliates with invalid email addresses or no email addresses. Notice will also be sent to all known non-affiliate creditors by U.S. Mail. Once the Claim Portal opens, you must then file your claim on the online Claim Portal, which will be found at [www.zeekrewardsreceivership.com](http://www.zeekrewardsreceivership.com). Starting **May 15, 2013**, you may request permission to submit claims using a method other than the Receiver's online Claim Portal by sending an email to the address [claims@zeekrewardsreceivership.com](mailto:claims@zeekrewardsreceivership.com) or mail to ZeekRewards Receivership, c/o GCG, PO Box 9964, Dublin, OH 43017-5964. However, permission to submit a claim outside the online Claim Portal will be granted only in rare instances, will be in the Receiver's sole discretion, and will be evidenced by a written acknowledgment to that effect from the Receiver. Such an acknowledgment will cite to the Court's May 8, 2013 order approving the Claims Process.

Our proposed Claims Process was designed to provide the greatest possible return to the investors and other potential creditors of the Receivership Defendant by minimizing the percentage of Receivership Assets we have to spend to reconcile and determine claims. In order to keep the costs associated with the Claims Process as low as possible, while at the same time being fair and equitable to potentially over 1 million claimants, we expect and anticipate the vast majority of claims will be required to be submitted through the online Claim Portal. The Portal will provide instructions on each screen and is designed to be user-friendly to all affiliates and other creditors. Additionally, I will provide updated FAQs regarding the use of the Claim Portal and the submission of claims once the Claim Portal opens.

**ALL CLAIMS MUST BE FILED SO THAT THEY ARE ACTUALLY RECEIVED BY THE RECEIVER TEAM ON OR BEFORE SEPTEMBER 5, 2013. Any claims submitted before the Claim Portal opens (on or about May 15, 2013) or after September 5, 2013 are automatically disallowed pursuant to the Order approving the Claims Process.**

As always, I greatly appreciate your continuing support and patience. I will post another update once the Claim Portal opens.
